



Local Rules Sheet

USGA Rules of Golf apply except for those modified by local rules

Ground Under Repair

- The following cultivated areas are mandatory relief (flower beds)
 - Hole #5 – right of the green
 - Hole #6 – behind purple tee box
- French drains and Irrigation line areas
- White circled areas deemed ground under repair

Obstructions: Any artificial surfaces, including roads and paths except for items that define out of bounds. If stance or swing is affected by surfaces that include retaining walls, black tubing, and the white fence behind the 2nd green, relief may be taken.

Out of Bounds: Margins are defined by white stakes or boundary fences

- 4 Hour Pace of Play or less. Please stay up with the group ahead of you.
- Appropriate attire is required including a collared shirt or golf mock.

Embedded Ball: Anywhere “through the green”

Electronic Measuring Devices: Allowed for regular and tournament play at Island View.
